

Meals Served [Full-Service]	1	lbs/meal
Meals Served [Limited-Service]	0.5	lbs/meal
Employees [Full-Service]	3,000	lbs/employee/year
Employees [Limited-Service]	2,200	lbs/employee/year
Disposed Waste ¹ [Full-Service]	66	% of disposed waste by weight
Disposed Waste ¹ [Limited-Service]	51	% of disposed waste by weight

What Is Technical Assistance?


- Evaluate existing waste streams





Waste Diversion as a Result of FY24 Hotline, Mini TA, and TA Activities


Type of Diversion	Annual Tonnage Diverted	Percentage of Total Diversion
Recycled	1,202 tons	68%
Reused	74 tons	4%
Reduced	1 ton	0.1%
Food Donated	3.5 tons	0.2%
Organics Diverted**	500 tons	28%
Total	1,781 tons	100%

1,781 tons diverted in FY24, contributing to 325,800 tons since 2013 199 businesses received technical assistance
